Church and School Ministry

As of March 2017, we are approximately \$ 120,000 ahead of budget due to:

- 1. Revenues above budget for both the church and the school along with keeping expenses down will give us the opportunity to have excess funds to contribute to the building expansion project.
- 2. It is amazing how the Lord has blessed us with a mild winter allowing for a savings year-to-date of \$ 25,000 in utilities alone.

Immeasurably More

Our "Reserve Fund" to meet our mortgage payment has remained steady throughout the year.

- ✓ Since the beginning of our current Capital Campaign through March 31, 2017 we have received \$1,099,200 in donations. Immanuel is blessed!
- ✓ Out of those funds we have made (22) months of payments at \$ 34,766 each \$ 764,850 (June 2015 through March 2017)

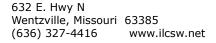
Our original goal was to raise \$ 1,500,000 with \$ 200,000 to go towards Capital Improvements. Balance need to reach our original goal \$ 400,800. Can we do it in the next 12 months?

The Immeasurably More Campaign ends April 12, 2018. It is hard to believe we are within one year of that date!

History for the BOD [Importance of not being without a Campaign in place]

Uplifting Capital Campaign ran from January 2012 to December 31, 2014. We were without a Capital Campaign from Jan – April 12, 2015.

At December 31, 2014, our "Reserve Fund" was \$ 159,905 – Between January 2015 and April 12, 2015 we received \$ 66,600 in donations for the mortgage payment and paid out \$ \$ 142,713, leaving a balance reserve of \$ 83,792 in the Uplifting Capital Campaign. Those "Reserve Funds" were moved to the Immeasurably More Reserve Fund.

Policy Writing

Personnel Policy along with the School Operations and Sexual Abuse and Molestation Prevention Policy has been completed. Photocopying and distribution will take place next week.

Updated Projection

2015-2016 our revenues came in 4.2% less than budget (\$ 34,000) therefore I was very conservative when budgeting revenues for 2016 – 2017 which accounts for our revenues being above budget year-to-date.

March 2017 was basically a break-even month therefore the projection from last month has improved.

At the May Voter's Meeting, I want to propose excess funds be applied 80% to Building Expansion and 20% to Property Repair & Maintenance same as last year.

Building Repairs

Painting & Wall Repairs:

- ≥ 2nd floor hallways, stairwells [scaffolding needed] and bathrooms on the 2nd floor 1st bid \$ 11,650.
- Multi-purpose building Lobby, Bathrooms and Cafeteria. Thoughts have been to try to organize some volunteers for that area. This would need to be done the first weekend of June.
- > There are classrooms in need of painting also.

Mats on wall in gym need to be re-anchored on the walls, some are sliding down and ruining drywall in the process.
